At Mystic Lake YMCA Camp, our goals are to teach youth social responsibility through environmental stewardship, community living and working with one another in a group setting that builds friendships. Youth develop and learn new skills to improve their sense of self-worth and confidence in an accepting environment where all are welcome.

Outdoor Education Instructor

General Function: Under the supervision of the Program Director, the Outdoor Education Instructor teaches classes and facilitates all aspects of school and retreat group's stay at Mystic Lake YMCA Camp including: programming and facility preparation. Outdoor Education Instructors must be at least 18 years of age and demonstrate good interpersonal and communication skills. This person must have an interest in learning to work with children in an overnight camp setting. The ability to demonstrate experience and knowledge in program development and implementation is necessary. Current certifications in Lifeguarding (including CPRPR and First Aid) are required for this position or the ability to be trained.

Job Requirements:

- 1. Attend Instructor training.
- 2. Supervise and teach all Education courses for 5th and 6th grade students.
- 3. Plan, implement and evaluate activities that are enjoyable and age appropriate for the campers including Trails, special programs and overnights.
- 4. Develop and implement new programs based on State of Michigan Education Curriculum.
- 5. Monitor general safety procedures for the entire camp.
- 6. Plan and implement large group activities.
- 7. Provide a positive role model for campers and fellow staff.
- 8. Maintain a positive working relationship with the education staff.
- 9. Work with other Senior Program Director to ensure that all program areas run efficiently.
- 10. Oversee the cleanliness and proper storage of program areas and equipment.
- 11. Properly complete necessary paperwork according to schedule.
- 12. Uphold risk management principles as set forth by the American Camp Association and State of Michigan Licensing Bureau.
- 13. Other duties as assigned.

Measurement of Performance





- 1. Campers will have a positive experience and want to return to camp.
- 2. Campers will be safe during activities.
- 3. A well balanced, diverse program will be achieved.
- 4. Staff will be provided with professional growth under the leadership of the Senior Program Director.
- 5. Camp facilities will be left in good condition at the end of each schools' program week.
- 6. All programs will be in compliance with accreditation and licensing standards.
